Overview

This report documents the knowledge sharing and learning activities of the Urban, Disaster Risk Management, Resilience and Land GP (GPURL) in FY23, from **July 1, 2022, through June 30, 2023.** The activities were organized and led by the six GSGs and their affiliated groups, consisting of 33 communities (Community of Practice (CoP)/Knowledge Silo Breaker (KSB)/global programs (Table 1 and Annex)) as well as the Tokyo Development Learning Center (TDLC), Global Partnership for Results-Based Approaches (GPRBA), Global Platform for Sustainable Cities (GPSC), and the GPURL Gender Group.



With the COVID-19 pandemic measurements were loosened, some of the activities in FY23 were carried out hybrid whereas most of them continued to be held virtually. **Learning activities** included online and hybrid BBB/BBLs, webinars, workshops, conferences, e-learning courses, Technical Deep Dives (TDDs) and the <u>GPURL Virtual Forum Lite</u>, for more information visit: <u>gpurllearning/</u>. In FY23 **127 learning activities** were delivered in total reaching 67 countries. As Figure 2 shows, BBB/BBL (31) and Webinars (26) were the most frequently organized learning activities. Table 4 is a snapshot of the learning activities conducted by quarter.



GPURL Forum Lite

In lieu of a face-to-face GP forum, GPURL delivered a virtual forum "lite" on April 24-27, 2023 consisting of a Townhall and a training program on Cities and Climate. The townhall included a video message from Juergen Voegele on the readout of the recent Spring Meetings, the Evolution Roadmap and the Paris Alignment. The technical training component presented global and regional perspectives, innovative operations, future directions for GPURL and advances in corporate climate commitments. The overall objectives provide a high quality professional and technical learning; provide a platform for all GP staff to set up the tone and expectations for the upcoming SD Forum and GP Learning Days; and strengthen sense of community and a common vision for GPURL and to network and build cross-regional synergies. The event was comprised of 7 sessions amounting to 7 hours of learning, 275 unique visitors with a high attendance of 231 on day 1. (Figure 3) See GPURL Lite Team Report here.

Global knowledge products and programs

Report on use of technologies to enhance own source revenue mobilization and property tax

The GSG completed a report titled "The Use of Technologies to Enhance Own Source Revenue Mobilization: Applications to the Property Tax", which will be published and disseminated in the early part of FY24. The report aims to provide World Bank task teams and Clients with basic tools and guidance regarding the use of technology applications to enhance own source revenue (OSR) mobilization. It documents existing and emerging technological applications and draws on relevant experiences of World Bank projects and technical assistance in this area through various case studies.

Report on assessment of constraints faced by urban local governments in accessing climate finance

The GSG has prepared a report on the various climate finance sources and instruments available to municipalities and urban local governments in developing countries, and an assessment of the constraints faced by municipalities in accessing these sources and recommendations to increase this access. This note is being prepared jointly with the United Nations Capital Development Fund (UNCDF). It is largely complete and will be finalized and published in FY24.

City Creditworthiness Initiative

The GSG has continued to oversee the City Creditworthiness Initiative global program, which has just concluded its phase 2 and is now starting phase 3 in FY24. A brief on this program is provided separately.

Supporting Bank Engagements on Urban Finance Issues

Review of global experience on Subnational development banks:

The GSG prepared a presentation reviewing the global experience on subnational development banks as vehicles for providing financing to municipalities and urban local governments for a high-level delegation of officials from the Indonesian Ministry of Finance and PT Sarana Multi Infrastruktur (PT SMI) visiting Washington DC in May 2023. The presentation and related dialogue informed the delegation's thinking on how to transform PT SMI to a National Development Bank to finance the development priorities of the 500+ local government entities in Indonesia.

Note on WBG engagement at subnational level as part of Evolution Roadmap discussions:

As part of ongoing senior management- and Board-level discussions on the WBG Evolution Roadmap, the GSG has overseen the preparation of a briefing note to senior management and the Board on the WBG's engagement at the subnational level. This note was prepared in collaboration with the IFC, MIGA and other Bank GPs and units (Governance GP and OPCS). It provided an overview of the WBG's existing activities and financial and technical support to subnational entities and indicated ways in which these activities could be expanded.

Events, Webinars and Trainings

Public event on performance-based financing for Urban Local Governments

• The GSG organized a <u>public event in February 2023</u> to launch the GP's report on "Performance-Based Financing for Urban Local Governments: Results and Lessons from Two Decades of World Bank Financing". The event was chaired by the Regional Director for Sustainable Development, Eastern and Southern Africa Region, and featured a panel discussion with representatives from Government counterparts from 5 countries that are implementing these types of programs/projects with Bank financing, including Ethiopia, Ghana, Kenya, Tunisia and Uganda; as well as the Director of Local Finance from the UN Capital Development Fund. The event was attended by close to 120 participants from within and outside the Bank.

Results-based financing (RBF)

• **RBF webinar series** – **Impact bonds:** The KSB continued its RBF webinar series by organizing a webinar titled "Financing impact" on insights on the use of impact bonds to achieve social and environmental outcomes (March 23). This session brought together internal and external experts in the impact bond space to provide a high-level overview of impact bonds globally, as well as drill deeper into the World Bank's early experience with this instrument. The webinar featured case examples presented by colleagues from FCI, Environment, and Education GPs.

• Performance-based financing for Subnational competitiveness (joint with FCI): The GSG and RBF KSB organized a webinar jointly with the FCI GP to discuss emerging innovations and operational lessons on subnational competitiveness, including a joint knowledge product "Subnational Competitiveness Grants Guidebook: A Tool to Promote Jobs and Economic Transformation in Cities and Regions by Leveraging Performance-based Financing". The webinar also discussed recent operational examples from Egypt and Nigeria where the PforR instrument has been used to support subnational competitiveness and local economic development.

Own-source revenue generation

- Learning week on land and property valuation in EAP: In May 2023 the Land and Urban teams held a learning week on land and property valuation in Korea. It presented eight study cases from ASEAN countries and 5 country experiences from non-ASEAN countries, covering various aspects of land and property valuation such as: Valuation Data and Standards for Transparency, Valuation Infrastructure, Market Data and Analysis; Education and Professions Capacity Building; Technology and Innovation; Mass Valuation and Recurrent Property Taxation.
- **Property Tax training course for clients:** As part of this learning week a training session on the World Bank's <u>Property Tax Diagnostic Manual</u> was also offered by professor Roy Kelly to an audience of 50+ participants for over 12 countries.
- Presentation of new publication "Managing County Assets and Liabilities in Kenya": The
 OSR KSB organized a discussion around the recently released book on Managing County Assets
 and Liabilities in Kenya that provides a summary of asset management issues in the context of local
 governments. It describes the pragmatic details of asset management frameworks, systems, and
 procedures, and it explains how they represent a sharp departure from a simplified accountingoriented approach to asset management.

<u>Urban Regeneration and Land Value Capture</u>

- At the request of various World Bank TTLs, the KSB organized urban regeneration-related site tours and presentations about global good practices in land-based financing and management of government real estate to the following delegations from Clients/counterparts: *Jamaica*'s Urban Development Corporation, Jamaica Social Investment Fund, Ministry of Finance (September 2022); *Saudi Arabia* (October 2022); Türkiye (November 2022). The KSB also presented land-based financing tools and urban regeneration global good practices to delegations, including from: *Costa Rica* Ministry of Housing of the Government (April 2023); *Indonesia*'s National development planning agency BAPPENAS (May 2023); *Georgia* National land agency (June 2023); and *Uganda* Ministry of Land, Housing and Urban Development (June 2023).
- The KSB organized a knowledge sharing event / webinar on "Mobilizing Finance through Anticipating the Economic Impact of Urban Infrastructure"

TDD on Property Tax and Land Value Capture

• Together with the TDLC, the GSG is currently organizing a technical deep dive (TDD) on land-based financing tools, property tax and land value capture. Preparations are well-advanced and the TDD will be held in O1 FY24

Communications and Outreach

• The GSG published <u>a new results brief</u> on the World Bank external website on performance-based financing to urban local governments. The brief also referenced the new report on the subject and other relevant links and was accompanied by social media messages.

Land and Geospatial GSG

Overview of Main Activities

The Global Solutions Group (GSG) on Land and Geospatial brings together more than 300 technical specialists and team members, across the World Bank Group working on land administration and geospatial

issues. It offers a platform for knowledge production, curation and exchange and innovation within and outside the Bank. The GSG's activities and services focus on the following areas: Analytics and Technical Assistance; Support to operations design and implementation; Knowledge curation and transfer to advance development solutions (including SSKE); Capacity building and technical training on the different subthemes to equip staff and clients with cutting edge knowledge; and Outreach and partnerships with internal and external partners, to advance the land agenda.

The GSG has an affiliated Knowledge Silo-Breaker - The Land Thematic Group (LTG) co-led by Mercedes Stickler and Sheila Kamunyori. In addition, there are several informal communities with the GSG including around geospatial data infrastructure, land and conflict, and women's land rights.




Figure 5. Snapshot of Land and Geospatial GSG Intranet Page

Below is a snapshot of the GSG activities in FY23.

1. Analytics and Technical Assistance

Land and Climate Action. The GSG is building the evidence base on the contribution of land
administration to climate change action by developing a high-level Position Paper and a Guidance
Note on Integrating Land Administration into Climate Change and Development Reports (Land
and CCDR Guidance Note). While the Position Paper aims to concisely highlight the ways that
land administration underpins climate action and targets senior decision-makers, the Land and

CCDR Guidance Note will provide more detailed justification and evidence to help CCDR task teams integrate land administration into the sector deep dive analyses and final CCDR synthesis report. These are forthcoming in FY24.

• Global Program for Women Land Rights. Working together with several partners, including Landesa, the Global Land Tools Network, Habitat for Humanity, the International Land Coalition, and others, the GSG helped launch the global advocacy campaign for Women's land rights "Stand for Her Land" (S4HL) in 2019 and has been advancing the campaign since. In addition, the GSG is preparing two regional stakeholder engagement strategies on women land rights - one for MENA and one for Africa Regions. Other outputs of the Women's Land Rights program include: the updating of the Gender in Land Administration Projects Toolkit (October 2022); and production of draft guidance notes on gender in property taxation and gender in property valuation (forthcoming in FY24).

2. Support operations design and implementation

The GSG and affiliated KSB members offered operational support and technical assistance to Bank project teams through technical support to project scope and conceptual designs, serving as panel members for QERs and peer reviews, support to MTRs, portfolio deep-dives and other types of implementation support.

The Land TG/KSB completed the <u>Global Map</u> of active and closed Land-related projects and ASAs. It includes information on 327 projects globally of which 40% are in Africa, 21% in Europe and Central Asia, 18% in South and East Asia and Pacific, 15% in Latin America and the Caribbean, and 6% in the Middle East and North Africa.

3. Convening, outreach and partnerships

• World Bank Land Conference 2024: The GSG plans to relaunch the World Bank Land and Poverty Conference in May 2024, which has been on hold since 2019. Consultations with development partners and internally found there is substantial multistakeholder interest in the Bank relaunching the Land Conference, which is the premier international gathering on the land sector, with a greater focus on incorporating evidence into operations and high-level policy dialogue with Clients. The GSG drafted an initial budget and framework for the conference and is preparing a PCN (September 2023) that will define the new conference vision, including an internal multisector working group and external steering committee. The 2024 theme is expected to focus on land administration as a foundation for climate change mitigation and adaptation.

Reengaging with FIG: The International Federation of Surveyors (FIG) is a global organization of land sector professionals – surveyors, land administrators, valuers, and others - from the public and private sectors and academia. This is an important global partner for the GSG and in the past there was a Memorandum of Understanding (MOU) between FIG and the Bank (represented by the GSG). This year FIG joined the S4HL campaign and is very interested in the Land Conference relaunch. The GSG plans to continue the reengagement with FIG and work on a new MOU. International Land Coalition (ILC). The Bank continues to support the ILC and sits on the Council and has since its founding. In collaboration with the ILC, the UK FCDO and others a Framework for Action - Land Tenure Security for People, Planet and Prosperity has been prepared. The GSG contributed to drafting the Framework for Action with a goal to scale up the global commitment to land tenure and land access. A small donor working group was established and the GSG participated in this working group. The framework for action calls for the organization of a global land summit, a new mechanism to monitor commitment to land tenure security and the establishment of a new platform for donor/government/civil society annual conference on land tenure security. This is also consistent with the GSGs relaunching of the World Bank Land Conference.

4. Learning Activities and Knowledge Products

The GSG and affiliated CoP/KSBs have organized 15 learning activities (Table 1) and delivered 11 knowledge products (KP) between FY22-FY23 (Table 2), including a new KP line, "Land Bites" – short summaries of the key achievements of World Bank land administration operations shared by email and PDF. The GSG also launched a website redesign effort in FY23 to make the website more useful to operational staff.

Resilience and Disaster Risk Management GSG

Overview of Main Activities

The Resilience and Disaster Risk Management (RDRM) GSG is organized around a knowledge management and communications platform in the Global Practices Portal for internal audiences. The RDRM Portal continues to grow its content, participation, and users.

The Portal offers curated content related to operations in topics such as <u>Cat DDO</u> and <u>CERC</u>, and just-in-time resources for RDRM operations. The RDRM Portal is populated daily with feature stories, news, blogs, projects, publications, events, as well as videos related to Resilience and DRM. The RDRM Portal intranet interface is intuitive and provides user-friendly features. It is one of the most viewed and visited intranet spaces within the Sustainable Development VP with 13,849 views and 5,507 visits in FY23. In FY23, the Portal hosted over 254 knowledge and communications products, including blogs, news, publications, and events.

A **Weekly Newsletter**, *Weekly Digest*, synthesizing the most important information on salient developments from the previous week and upcoming events on Resilience and DRM. The newsletter keeps the GSG members up to date and helps direct traffic to the rest of the GSG portal and content. The newsletter reaches 1,869 subscribers including the extended GPURL community. In FY23, 60 issues were

published including ten special issues, namely for International Day for Persons with Disabilities, ACP-EU DRM Focus Days, Nature-Based Solutions, Hydromet and International Day for Disaster Risk Reduction, Inclusive DRM and Gender Equality, Canada-Caribbean Resilient Facility, GFDRR Annual Report, Learning Days and Sub-Saharan Africa. Knowledge Repository & Just-In-Time support:

The RDRM Portal hosts curated and frequently updated resource pages. The RDRM knowledge team is currently working to put together regional resource pages such as the <u>LAC DRM</u> in addition to regularly updated repository for RDRM emergency response instruments <u>Cat DDO</u> and <u>CERC</u>. These pages include all project portfolio, guidance, and updates. For instance, we recently added publications on assessing the benefits and costs of nature-based solutions and building regulations in sub-Saharan Africa, as well as the Climate and Early Warning Systems (CREWS) Annual Report, among others.

Learning

The RDRM GSG provides learning resources such as a <u>series of self-paced e-learning courses</u> ranging from Safe and Resilient Cities to the Open Data Resilience Initiative, as well as webinars and workshops, including on data privacy and ethics and digital public goods for disaster and climate risk reduction.

Events

In FY 23 the communities organized 38 learning events. To further support the knowledge strategy several multimedia and social media tools have been used to further augment the experience and knowledge capture, dissemination and reuse for events and activities. The strategy includes use of a preevent, and post event knowledge package involving feature stories, blogs, publications. During the event, conducting video interviews and to further reach internal and external audience <u>Twitter feed</u> has been leveraged for during event updates.

Lessons Learned

One of the main lessons learned was to establish as the key priority, for the RDRM GSG knowledge management agenda, its alignment with the evolving strategic priorities of both the World Bank, GPURL and GFDRR. With respect to the Bank, the RDRM knowledge management agenda tailored its offerings to a regional structure. The RDRM portal enables users to search nearly 3,000 resilience and DRM knowledge products by region, topic and/or asset.

The second lesson learned, in line with the World Bank's <u>March 2021 strategic framework for knowledge</u>, is that the RDRM knowledge management agenda was committed to a "whole of Bank" approach which promotes knowledge sharing throughout the Bank. Beyond RDRM's home in the Urban, Resilience, and Land Global Practice, a large portion of our offerings already draw on knowledge and/or engage with a range of global practices, including Education, Environmental and Natural Resources, Health, Nutrition and Population, Transport, and Water, as well as global cross-cutting themes like Climate Change, Social

Inclusion, Gender and Fragility, Conflict and Violence. We learned that our Communities of Practices (CoP) or Knowledge Silo Breakers (KSBs) are the glue of these intersections and that they need to adapt, evolve and change reflecting the new development realities (N.B. Click for the link to our 13 KSBs).

Lastly, and in line with objective 1 of the GFDRR's 2021-25 strategy, the RDRM GSG knowledge management agenda in partnership with GFDRR was placing increasing emphasis on ensuring that knowledge generated and shared drives improvement in policy and practice. In order to achieve that, a top focus for the team was to bolster our efforts to listen, learn from and engage with policymakers and practitioners to better understand their knowledge needs and challenges so that we can tailor our offerings accordingly.

- Transit-Oriented Development CoP (210+ members): This CoP focuses on mainstreaming land use and transit planning and promoting sustainable urban development forms through operational support, knowledge exchanges, and partnership development.
- Urbanscapes KSB (260+ members): This KSB focuses on city planning, urban design, and leveraging
 public spaces/public municipal assets in urban areas for livable outcomes. The strategic focus areas
 include public urban spaces, urban fabric and placemaking, cityscapes, and streetscapes to help create
 productive, livable, inclusive, and vibrant cities.

Many cities around the world are facing a wide array of crises, from environmental crisis/climate change, public health issues, conflicts, and displacements to social inequality. The impacts of polycrisis have stalled decades of development progress, growth, and poverty reduction, and they continue to pose grave challenges to the provision of urban infrastructure and service delivery systems. To address the multifaceted challenges and support cities to move towards a green, resilient, and inclusive development trajectory, the GSGs and its affiliated CoPs/KSBs have provided a platform for coordinated action on key challenges by mainstreaming and scaling up urban sustainability considerations into Bank operations and strategic engagement with client countries and other development partners. The GSG and CoPs/KSBs have promoted knowledge exchange on a wide range of sustainable infrastructure and services topics through training of staff, portfolio reviews, knowledge dissemination, and learning events, development of guidance and technical notes, just-in-time technical assistance and operational support and collaboration with partners.

In FY23, the GSG and CoP/KSBs delivered 18 knowledge and 29 learning activities (Table 1 & Table 2). During the GPURL Forum Lite, the Sustainable City Infrastructure and Services GSG organized a three-day "Cities and Climate" training. The training focused on corporate commitments relating to climate, particularly the Paris Alignment process, and also delved into the challenges and opportunities of scaling up climate action alongside the core development priorities and explored ways to make the GPURL operations more strategic and adaptive to the ever-changing environment and climate. It also provided a forum to discuss the need to build multi-sectoral teams to create integrated and inclusive solutions,

collaborating with DRM, Planning, Environment, Land, Housing, Financing, Gender and Social teams to create greater impact and also the importance of carrying out strategic analytical work and global knowledge to prepare a new generation of projects that operationalizes the knowledge and findings from them (e.g., CCDRs, Thriving report, etc.).

The GSG and CoPs/KSBs also actively organized knowledge and learning sessions for external and internal audiences, while providing continued support through technical notes development, just-in-time technical assistance, and strengthening collaboration with partners. Highlights include technical deep-dives on Advancing Quality Urban Infrastructure and Cities and Climate Change, which were organized by the GSG and the Climate Smart Cities CoP in collaboration with the TDLC. Furthermore, a report "Cities, Culture, Creativity: Learning from the Republic of Korea's Experience" was jointly developed by the Korea Research Institute for Human Settlements (KRIHS) and the World Bank, highlighting the importance of cultural and creative industries (CCIs) for economic development. Furthermore, Smart Cities KSB – under the Global Smart City Partnership Program (GSCP) work program organized two in-person knowledge exchange programs in Korea and Barcelona, which provided a platform for client country delegations to meet with international experts on the ground. The team published three engagement briefs available at GSCP website and developed seven new case studies, which will be publicly available in FY24.

In addition, the Solid Waste Management Community of Practice (SWM CoP) actively engaged in various activities, including the OLC-KPOK Knowledge Exchange on SWM that took place in Seoul from May 1 to May 5, 2023. The event brought together delegations from several countries with ongoing World Bank engagements covering SWM, including Colombia, Indonesia, Jordan, Mozambique, Pakistan, and Tajikistan. The knowledge exchange workshop was part of the OLC's blended learning program on SWM, supported by the Korea Program for Operational Knowledge (KPOK) and funded by the Ministry of Economy and Finance (MOEF) of the Republic of Korea. The SWM CoP also conducted a webinar on creating sustainable livelihoods for waste pickers, which focused on inclusive recycling and social inclusion strategies that positively impact the lives of waste pickers. The session featured a presentation by Roots for Sustainability (R4S), which shared their experiences working with waste pickers in various countries, demonstrating how collaboration and increased social and economic recognition have benefited these communities. SWM CoP also organized a field visit to the solid waste facilities in Prince George's County, Maryland. Participants had the opportunity to observe the processing of yard waste and food scraps at the Organics Composting Facility, the single-stream recycling operations at the Materials Recycling Facility, and the Brown Station Road Sanitary Landfill that included a gas collection and electricity generation plant. Also, Urbanscapes KSB organized a webinar with Women in Informal Employment: Globalizing and Organizing (WIEGO), reflecting on innovations in urban informal economy management and support and drawing on detailed in-city work in Lima, Dakar and Delhi. Panelists discussed past and current innovations in urban design, participatory planning, and law and infrastructure provision. It also delved into unprecedented challenges workers are facing and responses needed to secure livelihoods going forward.

Moreover, in line with the corporate strategy and the GP's strategic priority on the climate agenda, a new Cities and Climate Change platform (<u>internal</u>; <u>external</u>) was launched in December 2022. The platform houses the World Bank's latest news, corporate requirements, research, and global programs related to cities, as well as different tools offered to help cities plan for and prioritize their climate action.

Figure 9. Cities and Climate Change Website



Territorial and Spatial Development GSG

Overview of Main Activities

Creating Knowledge: the GSG and its members continue to push the knowledge boundaries to inform our policy dialogue. Most notable from FY23 is the SD Practice Group Flagship report Thriving: Making Cities Green, Resilient, and Inclusive in a Changing Climate, which already had over fourteen thousand downloads by the end of June. A close collaboration with the Poverty & Equity GP led to a joint note on Estimating Urban Poverty Consistently Across Countries. The team has also been working closely with the office of the Chief Economist in LAC supporting the upcoming flagship looking at productivity in the region through a spatial lens – so keep an eye out for the report next FY. Also in LAC, the team focused on urban challenges in the Brazilian Amazonian, work published in chapter 6 of the Amazon Economic Memorandum; the team is also contributing to the North East Brazil Economic Memorandum as well as the Peru CEM, which will be coming up next FY. Meanwhile, in EAP, the team led work on a regional study Unlivable: What the Urban Heat Island Effect Means for East Asian Cities that is expected to be launched in the Fall. 


Figure 10. Snapshot of Territorial Development GSG Intranet Page

Operational Support: the GSG continued its operational support across regions. The Lesotho CPF included a strong focus on territorial development, in line with government's objectives. Teams are complementing this with an ongoing ASA on territorial development challenges. In South Africa, the team is supporting the design of the Mpumalanga Economic Diversification and Industrial Strategy, which is a key part of the country's just transition away from coal. In Jordan, the GSG is providing technical guidance for neighborhood selection for the Jordan Smart and Inclusive Urban Mobility Project (P176451), including

assessment of impacts of transit investments. In LAC, the team has supported discussions on the contours of an IPF in Peru focusing on regional development. In Central America, the team recently completed an exercise to identify priorities for cities with a spatial lens. To deepen the cross sectoral discussions, a new series of Territorial Development Dialogues in LAC started this year [go here for video and link to presentations].

Building the Data Foundations: Building on the Global Monitoring Database (GDM), the team created spatial inequality indicators for over 103 countries across 5 continents covering the period since 2000. The data has been published under the "Spatial Inequality Database" on the Development Data Hub (here). The team has also been working to update the Competitive Cities database and competitive cities benchmarking tool. Keep an eye out for this, along with the launch of the *Thriving* data dashboard, which will provide an interactive web mapping platform for the data which underpins the SD Flagship report.

Knowledge exchanges: with over one event per month, FY23 was a very active year for the GSG from the knowledge exchange perspective. Flagship events included the WB Live Launch of the Thriving report on cities and climate change and its earlier soft launch at COP-27. The GSG was co-organizer of the 16th North American Meeting of the Urban Economics Association (UEA) —which was hosted for the first time at the World Bank. We also co-organized with DEC-RG, GWU and IGC the 7th Urbanization and Poverty Reduction Research Conference. At the beginning of the FY, the GSG co-organized with the Poverty & Equity GP a training event on the "Integration of the Consistent Measurement of Urbanization into Global Poverty Measurement." We also started a new Sustainable Cities Workshop Series, co-organized with George Washington University, holding two half day workshops, the first of which focused on Urban Public Finance & Governance [include link] and the second on Urban Inclusion and Development. We expect to continue this series this FY so stay tuned for new areas of focus. Finally, three clinics to support CCDR teams were held throughout the year. Urban Poverty, Inclusive Cities and Housing GSG

The Urban Poverty, Inclusive Cities and Housing (UPICH) GSG focuses on issues related to urban poverty, inclusion, slum upgrading, low-cost housing, resilient housing, and solutions for addressing increasing issues of migration and forced displacement.

Along with the affiliated KSBs, the GSG serves as an ecosystem for generating, disseminating, and curating knowledge as well as for advising and contributing to teams working on operationalizing knowledge and best practices in the areas of focus.

The Urban Poverty, Inclusive Cities and Housing GSG aims at fostering a community around key topics related to urban poverty and housing for: knowledge sharing, operational support, training activities, mentoring and building partnerships across the World Bank Group and beyond. The GSG focuses on the following activities based on the demands of its membership:

Learning

The GSG has organized formal learning activities that brought internal and external partners and clients together to dig deeper into important issues around urban poverty, inclusion, and affordable housing. Examples in the FY23 include a Technical Deep Dive (TDD) and many other webinars on several topics, including—but not limited to— affordable housing, jobs and local economic development, tracking population movements in FCV, and universal accessibility in urban design, urban planning in informal politics, social and affordable housing, smart and inclusive cities. All events could be found on the GSG SharePoint site. Some of the highlights are as such:

- <u>Virtual Technical Deep Dive (TDD) on Affordable Housing</u> was organized by TDLC in collaboration with the GSG and Affordable Housing KSB from October 17 to 21, 2022. The TDD was designed in a way that most effectively highlights the World Bank's clients' needs at a global level to better understand constraints and opportunities in the sector, improve the targeting of limited public resources, and mobilize the private sector in the delivery of affordable housing.
- New initiation for mainstreaming Universal Accessibility (UA) in Urban Operations kicked off. Through the QII-funded mainstreaming UA initiative, Inclusive Cities KSB team has been working with two pilot projects: Senegal Affordable Housing Development Project (P174759) and Yemen Integrated Urban Services Emergency Project II Additional Finance (P178270). The team mobilized two UA experts in September 2022 and subsequently, hired a firm and awarded the contract in January 2023 to a consortium led by a French-based firm, Urbaconsulting. An internal technical workshop was conducted on October 20, 2022, which focused on the needs of the supported projects in Senegal and Yemen. Then the initiative was formally launched through an event on March 2, 2022.
- Affordable Housing KSB co-organized the <u>9th Global Affordable Housing Conference</u> in collaboration with the FCI GP. A session on Affordable Housing and Artificial Intelligence was featured.

Knowledge Development and Sharing

The GSG and its affiliated KSBs are supporting operations and the development of new knowledge pieces based on areas of emerging demand:

- With support from GAP Fund, the Slum Upgrading KSB has developed a knowledge note on Low Carbon Slum Upgrading. The note discusses possible entry points for low carbon approaches to slum upgrading, illustrates practical, affordable and adaptable low-carbon solutions for slum upgrading at the household level and neighborhood level, and highlights key considerations and lessons in the planning and implementation of low carbon interventions in slum upgrading. The guidance note is introduce through an event on January 24, 2023
- A Guidance Note for Task Teams on Cities, Jobs and Local Economic Development was finalized and disseminated. The work was led by the Urban Poverty, Inclusive Cities and Housing and the Inclusive Cities team contributed through a GPURL FY22 portfolio review from a jobs and economic inclusion perspective. The note was internally reviewed and disseminated through an event on May 23, 2023.
- The GSG's affiliated KSBs, namely the Inclusive Cities KSB and Affordable Housing KSB, have published **regular newsletters** to update task teams about the subject matter.
- The GSG and KSBs also serve as a support mechanism for Bank operational teams by providing just-in-time technical advice and support through different channels such as **email distribution lists and an internal** <u>SharePoint site</u>.

Partnerships

Internal and external partnership building is another primary objective of the GSG. The team has focused on solidifying internal partnerships, such as with FCI (e.g., through the Affordable Housing Conference affiliated event that FCI led), the GPURL Gender Group, the Social Inclusion GSG, and Competitive Cities KSB. It has also strengthened relations with external partners such as Habitat for Humanity, Cities Alliance, Slum Dwellers International, REALL, and WIEGO.

Affiliated KSBs and Global Programs

The GSG comprises four KSBs and Global Programs:

- The Affordable Housing KSB supports current operations and responds to growing client demand in the housing sector across regions.
- The Cities, Migration and Forced Displacement KSB aims to improve knowledge exchange and enhance operational approaches to address migration and forced displacement in cities and towns through activities such as advisory services and analytics for investment operations, project support for results and impact studies, and knowledge and information sharing.
- The Inclusive Cities KSB promotes an integrated approach to spatial, social, and economic inclusion within cities. The objectives of the KSB are to enhance understanding of exclusion in cities and share ways to improve inclusion in urban areas through a multi-dimensional approach. In doing so, the KSB focuses on supporting operations, facilitating knowledge exchange and peer learning, and building a network among GPURL and cross-GP colleagues as well as external partners.
- **Slum Upgrading KSB** is comprised of staff working to advance the practices aimed at achieving inclusion in cities. It provides a platform for exchanging knowledge and experiences, responding to demands for operational support, identifying opportunities for scaling up operational responses, and capacity building opportunities for staff and clients.

The GSG and its affiliated communities delivered 4 knowledge (Table 18) and 16 learning activities (Table 19) in FY23.

Tokyo Development Learning Center (TDLC)

Technical Deep Dives and Workshops

Technical Deep Dives (TDDs), TDLC's flagship activity, are a week-long, cohort-based knowledge sharing program for World Bank clients and staff engaged in projects in developing countries aimed at sharing key global and Japanese best practices to generate actionable solutions for WB projects related to urban development. The TDDs comprise various immersive knowledge exchange activities that include presentations by experts, site visits, group discussions, and action planning.

While COVID-19 related travel restrictions impacted the delivery of the TDDs in Q1 of FY23, TDLC returned to in-person delivery of TDDs in January 2023, albeit scaled-down, after a near three-year of virtual modality. In total, TDLC delivered five TDDs, one virtual and four in-person, attended by 149 country representatives from 37 countries, and 51 World Bank TTLs. In aligning with the priorities of the World Bank Group's Evolution Roadmap and the government of Japan, the TDD incorporate topics such as, climate change, post-conflict recovery, and quality infrastructure investments (QII). Return to in-person TDDs, prompted new ways of delivering knowledge-exchange, such as "in-city" TDDs where the entire TDD is hosted in one Japanese city to deepen the experiential learning of TDD participants, and "regional" TDDs that are structured to benefit a particular region (i.e ECA region for the knowledge exchange on postwar reconstruction and recovery held in Hiroshima).

To date, TDLC has organized five TDDs:

TDD on Affordable Housing (Online: October 17–21, 2022)

The TDD on Affordable Housing was organized by TDLC in collaboration with the Affordable Housing Community of Practice as a virtual event that aimed to "provide knowledge exchange opportunities on tools and approaches that governments can introduce and implement to support the strengthening of formal housing markets with a particular focus on low-income market segments". This TDD was anchored in three core themes namely: Constraints and Opportunities on the Housing Value Chain; Segmentation of the Housing Market; and Mobilization of the Private Sector Delivery.

Through this TDD, the participants examined the primary problems of affordable housing provision in their respective countries, which included: a.) Increasing urban sprawl; b.) Absence of adequate funding mechanisms and private sector involvement in housing provision; c.) Housing supply unable to cope with increasing demand for housing.

The TDD informed 12 WB projects with an estimated amount of USD1.9billion and with about 4.1 million potential project beneficiaries. The virtual modality of this TDD enabled the participation of 10 countries, namely: Cameroon, Comoros, Djibouti, Dominican Republic, Ghana, India, Indonesia, Maldives, Philippines, and Rwanda. A total of 116 participants attended this event, which comprised of 69 country representatives and 17 Task Team Leaders, 16 technical resource persons and 14 observers.

TDD on Advancing Quality Urban Infrastructure (F2F: January 30–February 3, 2023)

Together with the QII Partnership and the Sustainable City Infrastructure and Services GSG, TDLC held this TDD with the objective of "developing operational understanding of QII principles (that is, sustainable development, economic efficiency, environmental considerations, disaster resilience, social considerations, and governance) and how these can be applied in addressing urban development problems and in project implementation." The TDD covered four key topics: (1) key elements of quality infrastructure investment; (2) green, resilient, inclusive infrastructure design; (3) economic efficiency and mobilizing finance for

quality infrastructure investment; and (4) leveraging digital transformation for urban infrastructure and services.

The TDD, which was the first in-person TDD in three years, informed 14 World Bank projects amounting to an estimated US\$ 3.3 billion and with about 14.9 million potential project beneficiaries. Nine countries participated the TDD: Cambodia, Ethiopia, Jamaica, Madagascar, Morocco, Senegal, Pakistan, Turkey, and Vietnam. Twenty-three representatives and 9 Task Team Leaders, of which 11 were female attended the TDD (table 13). Ten (10) Japanese experts and 9 international experts were mobilized to support this event.

TDD on Nature-Based Solutions for Climate Resilience (F2F: February 20 – 24, 2023)

TDLC organized this TDD in collaboration with the Global Program on Nature-Based Solutions (NBS) for Climate Resilience and GFDRR's Tokyo DRM Hub. The TDD explored the design and implementation of nature-based solutions and provide better understanding of how resilience can be designed for cost-effectiveness, sustainability, and restoration of biodiversity. This TDD focused on three core themes: Flood Risk Management, Engaging Communities for NBS, and Designing Urban NBS.

This TDD informed 10 World Bank projects amounting to a combined US\$1.4 billion and around 21.9 million potential project beneficiaries. Nine countries participated in this event: Cambodia, Cote d'Ivoire, Honduras, Indonesia, Jordan, Rwanda, Sri Lanka, Uzbekistan, and Vietnam. Seventeen country representatives and 11 Task Team Leaders, of which 11 were female, and 9 observers attended the TDD. TDLC engaged 14 Japanese experts and 8 international experts to share their knowledge in this activity.

Housing and Urban Recovery: Knowledge Exchange in Japan on Urban Crises (F2F: March 13 – 16, 2023)

This event was designed as a region-focused knowledge-exchange responding to a regional demand for a common knowledge theme with the objective of providing the opportunity to learn from the Japanese experience in managing crises, specifically lessons from the City of Hiroshima in recovering after the war and the incremental and bottom-up process of post-war reconstruction. The activity consisted of knowledge-exchange workshops that covered three themes: Emerging Crisis in Europe and Central Asia; Experience of Hiroshima in Postwar reconstruction; and Building green, resilient, and inclusive cities after the crisis.

The knowledge-exchange informed eight World Bank projects amounting to an estimated US\$ 254million and 0.04 million expected beneficiaries. Eight countries attended the activity: Azerbaijan, Croatia, Greece, Kosovo, Kyrgyz Republic, Poland, Romania, and Ukraine. Twenty-three country representatives and 9 Task Team Leaders (of which 16 were female), participated in this activity. Eleven Japanese experts and 14 international experts served as technical resource persons.

TDD on Cities and Climate Change (F2F: April 17 – 21, 2023)

This TDD was organized by TDLC together with the Sustainable City Infrastructure and Services GSG, GFDRR, and the Climate Smart Cities Community of Practice (CoP). It provided an opportunity for World Bank client country delegations to develop a deeper understanding of good practices in urban climate adaptation and mitigation, including transit-oriented development and resilient infrastructure, nature-based solutions, resilient and energy efficient buildings, and solid waste management. This TDD focused on four themes: Solid Waste Management; Resilient Green Buildings; Nature-based Solutions; and Resilient Green Transport and Transit-Oriented Development (TOD).

The TDD informed nine World Bank projects amounting to an estimated US\$ 1.5 billion and potential project beneficiaries of about 7.4 million people. Eight countries participated in this event: Indonesia, Jordan, Kenya, Nepal, Nigeria, North Macedonia, Peru, and Vietnam. Eighteen country representatives and 8 Task Team Leaders (of which 10 were female) and 1 observer attended the TDD. The technical resource persons mobilized to share knowledge in this activity included 12 Japanese experts and 7 international experts.

Other Key Events Hosted/Co-hosted by TDLC

In addition to the TDDs, TDLC hosted/co-hosted other key global events:

13th Asian-Pacific City Summit side event on Healthy Cities in Action: Maximizing Health Co-Benefits of Inclusive Urban Investments (Hybrid: July 28, 2022)

At the request of Fukuoka City on July 28, 2022, TDLC held, a side event for the Asia Pacific City Summit: a panel discussion on Healthy Cities in Action: Maximizing Health Co-benefits of Inclusive Urban Investments. This panel discussion introduced relevant domestic and international local government policies and private sector initiatives that promote healthy and inclusive community development. The 184 attendees deepened their understanding of healthy city initiatives in Japan and abroad. Fukuoka City and Kobe City were selected as examples from Japan, and participants deepened their understanding of the efforts being made in each city to improve healthy life expectancy and to create a city that makes the most of nature and information and communications technology.

International Symposium "From Recovery to Growth: Learning from Hiroshima's Experience" – Dialogue between Hiroshima, Ukraine, and other Eastern European and Central Asian Countries (March 15, 2023). (F2F: March 15, 2023)

To commemorate Hiroshima becoming the seventh city to join the CPP, TDLC and the City of Hiroshima co-organized an international symposium on the theme of reconstruction and growth. About 500 people gathered from Hiroshima City and beyond, including government officials, private businesses, researchers, and the general public. The event featured video messages from Prime Minister Fumio Kishida and World Bank President David Malpass, as well as remarks from Deputy Finance Minister Kentaro Ogata, Hiroshima Governor Hidehiko Yuzaki, and Hiroshima Mayor Kazumi Matsui.

Juergen Voegele (Vice President for Sustainable Development, World Bank) spoke on behalf of the World Bank and stressed that urban areas are vital for economic growth and opportunities, because they provide solutions to various developmental complications. He highlighted the adaptability of cities to rebuild themselves, becoming more green, resilient, and inclusive, just like the city of Hiroshima has accomplished. Anna Yurchenko (Deputy Minister for Communities, Territories and Infrastructure Development of Ukraine for European Integration) delivered the keynote presentation, expressing her belief that Hiroshima represents reconstruction and prosperity and that Ukrainians can follow suit in rebuilding their society for the better.

A music session, navigated by the mayor of Hiroshima, featured orchestral and choral performances and a slide show on the destruction and reconstruction of Hiroshima and the culture of peace, which captivated the audience. During the panel discussion moderated by Juergen Voegele (Vice President of Sustainable Development, World Bank), notable figures such as Kenichi Susume (Deputy Mayor of Hiroshima City), Oleksandr Syenkevych (Mayor of Mykolaiv, Ukraine), Azamat Mambetov (First Deputy Minister of Emergency Situations, Kyrgyz Republic), Nargiz Garajayeva (Senior Adviser, Office of Special Representation of the President, Azerbaijan), and Sameh Wahba (Regional Director, Sustainable

Development, Europe and Central Asia, World Bank) discussed key challenges and initiatives around reconstruction efforts.

Conclave on Urbanization and Development in Fragile Mountain Ecosystems (April 5-6, 2023) (F2F: April 5-6, 2023)

TDLC served as one of the technical partners to organize a two-day conclave on Urbanization and Development in Fragile Mountain Ecosystems, jointly hosted by the High-Level Committee on Urban Planning, constituted under the Ministry of Housing and Urban Affairs, India and the Administrative Training Institute, State of Uttarakhand, India, and was held in Nainital, Uttarakhand, with participation from Himalayan towns in Bhutan, Nepal, and India.

TDLC mobilized two experts from Japan as speakers: Susumu Oikawa, deputy mayor of Hiroshima City and Takeshi Suzuki from MLIT. For Day 1, in "Session III: Innovative Data and Technological Tools to Improve Urban Planning of Mountain Cities," Deputy Mayor Oikawa presented on "Reconstruction and Community Development from Torrential Rain Disasters" which was based on the city's experience. For Day 2, in "Session V: Urban Regeneration and Renewal: Infrastructure and Service Provision in Himalayan Cities", Takeshi Suzuki presented on "Urban 3D Model PLATEAU: Initiatives of the Japanese Digital Twin" to showcase the latest digital data tool in Japan and its application in urban planning.

The conclave facilitated an exchange of knowledge and best practices from five participating countries with 150 participants from more than 30 cities. Representatives from national, subnational, and local governments from Bhutan, India, Japan, Nepal, and the Republic of Korea made presentations on solutions and approaches to effectively respond to the challenge of development in the Himalayas. The presentation touched upon topics such as urban planning in different spatial contexts, impact and approach towards floating/tourist population, urban renewal and upgrading, land use planning, and risk-based master plans. At the closing of the conclave, the Nainital Declaration —co-signed by the Urban Development Directorate, government of Uttarakhand, Administrative Training Institute, state of Uttarakhand, and the High-Level Committee on Urban Planning — was announced as a statement of purpose to work towards a "green, resilient and inclusive future for Himalayan cities in India".

Global Partnership for Results-Based Approaches (GPRBA)

Established in 2003, the Global Partnership for Results-Based Approaches (GPRBA) supports the World Bank's work of building inclusive, resilient, and sustainable cities and communities, using innovative results-based financing instruments to help address the many development challenges that the world faces today. GPRBA's results-based financing (RBF) approaches provide access to basic services like water and sanitation, energy, health, and education for low-income families and communities that might otherwise go unserved. By linking payments to actual results achieved, and through its explicit and unique pro-poor focus, GPRBA fosters inclusive development and helps address service delivery gaps arising from the challenge of increased urbanization in developing countries. It creates financial incentives for service providers to extend basic services to low-income communities, while also providing incentives for consumers in these communities to access the services. In addition to bringing together public and private sector funders to maximize resources and designing effective incentives for service providers to reach underserved low-income communities. GPRBA produced 5 knowledge products (Table 23) in FY23. Knowledge sharing activities includes publications, videos, and external event participation by GPRBA team members.

GPRBA's flagship knowledge event, RBF Forum 2023, was held in Nairobi, Kenya from May 22-25, 2023. The forum served as a platform for showcasing impactful projects, unveiling evidence of results-based financing (RBF) approaches in development, fostering knowledge exchange among RBF practitioners, and thought leaders, and facilitating invaluable networking opportunities.

GPRBA started revamping GPRBA website that is supposed to be finalized in early FY 24 GPRBA continues to disseminate news and publications through its "Results Matters" quarterly newsletters that counts over 3,000 subscribers.

Global Platform for Sustainable Cities (GPSC)

The Global Platform for Sustainable Cities (GPSC) is a knowledge platform managed by the World Bank's GPURL. Led by GPURL and financially supported by the Global Environment Facility (GEF), the platform has been coordinating GEF's Sustainable Cities Program since 2016. GPSC has convened and led multistakeholders across the globe and the broad spectrum of urban issues, built on its three pillars: Planning, Financing, and Measuring. GPSC's multi-sectoral activities have been delivered through diverse channels and have contributed to policy development, planning, implementation, and capacity-building programs at the local, national, regional, and global levels and provided direct support to the city projects.

During the FY23, the GPSC organized 5 knowledge and 6 learning activities. Some of the major activities include the two deep-dive learning events: the first one, "Greening Cities: Urban Nature and Biodiversity – Promote "Nature-positive" Development" was held in November 2022 in Paris in collaboration with the Paris Municipality and AFD and delivered in a hybrid format. The 4-day learning event was designed to provide an interactive platform to learn and exchange ideas on urban nature and biodiversity across four thematic areas; i) Overview of urban nature and biodiversity, ii) Managing urban nature and biodiversity, iii) Incorporating urban nature and biodiversity into spatial planning/urban form, and iv) Incorporating urban nature and biodiversity into project design and financing. 100+ attendees joined in-person and 150+ people participated online, comprised of city representatives, urban practitioners from around 50 cities across 23 countries, as well as experts and senior officials from the partner organizations.

From April 24-28, 2023, it organized another deep-diver learning on "<u>Urban Heat</u>," which focused on (i) incorporating climate adaptation and cooling solutions into planning, (ii) holistic approach to urban cooling solutions including nature-based solutions, passive and active cooling options such as district cooling, (iii) policy and regulatory framework for implementation as well as approach to financing. The program was structured to highlight the process and approach to tackling urban heat challenges drawing from case studies in Singapore and international best practices, including Paris and Guangzhou, providing a platform for knowledge exchange and deep-structured collaborative learning for participating cities of Cambodia, China, Indonesia, Paris, Philippines, Poland, Thailand, Uzbekistan, and Vietnam.

GSPC was also actively engaged online knowledge sharing activities. During FY23, GPSC's website (www.thegpsc.org) had 81,679 views and 44,435 unique users. In terms of online communication, the newsletters reached almost 3,300 recipients on average, which include World Bank colleagues, partner organizations, city leaders, urban practitioners, research institutions, and students around the globe.

GPURL Gender Group

To facilitate knowledge sharing of gender-inclusive practices and models, GPURL established the GPURL Gender Group (GG)in FY20 to provide a more systematic gender tag review process and more support for task teams in meeting gender tagging requirements.

The GPURL GG provides support to teams through a network of regional focal points. The main objectives of the Gender Group are:

- Enhancing the impact of GPURL's efforts to mainstream and promote gender inclusion in operations through knowledge creation, curation, capacity building, and partnerships.
- Providing easy and accessible information on good practices on gender in Urban Disaster Risk Management (DRM) and Land.
- Sharing resources, including knowledge briefs, guidance notes, sample TORs, and results stories for WB teams on gender in Urban, DRM and Land.
- Supporting operational teams with the gender gap analysis and development of the gender results chain for the gender tag.


In FY23, the team continued to produce a , started in March 2020, to share best practices, reports, and other documents on gender in GPURL. The GPURL Gender Group launched a Guidance Note <u>How to Identify Gender Gaps in Disaster Risk Management Projects</u> and a new and improved toolkit "Integrating Gender in Land Projects: A Toolkit The GG team organized the following <u>training and knowledge events in FY23</u>:

- Gender and Forced Displacement in Cities consultation workshops on January 18, 2023 and December 12, 2022
- Gender Issues in Solid Waste Management October 6, 2022
- Who's at the Table? Centering Gender in Urban Resilience Projects January 23, 2023

The GG team also completed a portfolio review of GPURL operations and gender tagging for FY21-22 (adding to the previous portfolio review for FY18-20) which provided the data for a <u>five-year trend analysis</u>, and an <u>Implementation Review of GPURL IPF operations</u> to assess the status of gender tagged operations (approved between FY2018-20) in the GPURL portfolio and their current progress toward closing their identified gender gaps.

Finally, the team launched a <u>database of strong gender tag results chains</u> that is searchable by topic, country, and region and which is now operational on the GPURL Gender page.
